Position Purpose:

The Statewide Health Promotion team at Dental Health Services Victoria (DHSV) works collaboratively with other sectors to build the capacity of professionals and organisations to promote oral health, particularly in the early childhood, disability and health sectors.

This role works within the Health Promotion team, delivering the Healthy Families, Healthy Smiles (HFHS) program. HFHS aims to improve the oral health of Victorian pregnant women and children aged 0-3 years through capacity building of health professionals and early childhood professionals. As a part-time (0.8 FTE) Health Promotion Officer, you will work towards the development, delivery, evaluation and review of a range of oral health promotion initiatives, for Victorian population groups with high risk of poor oral health outcomes.

Role Accountabilities:

Role Specific

- Actively support the planning, design, implementation and evaluation of HFHS initiatives, including education/training packages
- Application of strong project management strategies including achievement of agreed deliverables in a timely and effective manner.
- Maintain the strengths of existing partnerships and develop new relationships to build the profile of HFHS and DHSV's statewide oral health promotion.

- Advocate for oral health promotion to be embedded in everyday practice of early childhood and health professional and their service settings.
- Build oral health literacy by ensuring that information developed and disseminated by internal and external partners is consistent, evidence-based and accessible.
